New or transferring members pay an extra \$10 that is a total of \$98 for Club dues and the NCGA membership. A "NEW" membership also means switching clubs and transferring your membership affiliation from your current club, e.g. EClub Monterey Bay or Poppy Hills or the PG Men's Club, to PGSMGC. You will keep your same GHIN #, however, if your NCGA membership has lapsed for a year or more your old GHIN # may or may not be available.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

I am aware that the sport of golf -- including my participation in events of the Pacific Grove Senior Men's Golf Club (the "Club") — involves risks, dangers and hazards. Such risks, dangers and hazards include, but are not limited to, walking on difficult and uneven terrain, errant golf balls, golf carts overturning or colliding, wild animals, water hazards, sand hazards and latent hazards. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting therefrom. In consideration of the Club's acceptance of my membership and agreeing to my participation in events organized by the Club, I hereby agree as follows:

1. To waive any and all claims that I, or anyone claiming on my behalf, have or may in the future have against the Club and its directors, officers and other representatives (collectively, the "Releasees") and to release the Releasees from any and all liability for loss, damage, expense or injury, including death, that I may suffer;
2. To hold harmless and indemnify the Releasees for any and all liability for any property damage, loss or personal injury to any third party resulting from my participation in any Club events;
3. This release agreement shall be effective and binding upon my heirs, executors, administrators, assigns and representatives;
4. I confirm that I have read and understood this release, waiver and indemnity agreement prior to signing it, and I am aware that by signing this agreement I am waiving certain legal rights which I or my heirs, executors, administrators, assigns and representatives may have against the Releasees.
